Create an Account

- On the Create Account page, select your school system from the drop-down menu on question 1.
- For questions 2 – 4 enter your contact information. Be sure to double check the email address entered to assure there are no extra spaces or typos.
- If you (the applicant) are also the Special Education Director for the school system, select 'Yes' for question number 5. You can then proceed to **CREATE ACCOUNT**.
- If you are not the Special Education Director for your school system, select 'NO' on question 5. You must then enter the name and email address for your Special Education Director before clicking **CREATE ACCOUNT**.
- If an account has already been created using the email address you entered, you will receive the following message: **An Account has already been created using this Email Address**. In this case you can proceed to login because you have already created an account. If you did not previously create an account with this email address or if you forgot your login and password, please email support@gemschoolsoftware.com.

Student Information Page

Each page has fields that are required before the application can be submitted. All of the fields on this form are required except for a Second Disability and Parent/Guardian (2). However, if you enter a name for Parent/Guardian (2) you will be required to enter their contact information.

Once you are ready to leave the page, you can either choose to return to the Menu or go to the next page using the navigation links at the bottom of the page.

Menu & Application Table

Once you have entered the student's name on the Student Information form and click **Post/Update**, it will create a new row on the **Applications Table** on the **Menu**.

Each application will be organized by the student's last name. A unique Application ID will be created for each application and you will see the ID listed below the student name. If you click on the student's name, you will return to the Student Information page.

Each of the other application sections are accessible through the corresponding buttons in the application row. Sections that are not complete appear in red, so you will know instantly which sections and applications are not complete.

Each school system is allowed a certain number of applications per any given school year based on the October child count. The number of applications allowed for your school system is listed at the bottom of the Applications Table. You will not be able to create more applications than are allowed for your district.

Update Special Ed Services

Near the bottom of the **Cost Worksheet**, you will see the **Cost Worksheet Summary**. This table calculates the amount entered in the tables above. Three times the annual cost (#5 which is \$27,000) and any amount entered into the Third Party Funds table (#6) will be automatically deducted from the Total Cost of the Child (#4). The last line (line #4 minus line #5 and #6) is the **Total Allowable GHCF**. On the bottom of the table you must select State/Local and/or IDEA funds as the funding source the grant will reimburse and click **Update Funding Sources**.

IEP Upload

You must provide a copy of the student's current Individual Education Program (IEP) outlining the services for the high cost child. You may upload more than one IEP to cover the time period of this grant application. Each time you upload an IEP, a new blank row will be provided to upload an additional IEP. Please include the Start and End Dates for each IEP.

To upload a PDF:

1. Enter the beginning and ending dates of the IEP and click **Update IEP Dates**
2. Click the **Browse** button to navigate to the document on your computer
3. The document selected must be a PDF file
4. Click the **Open** button on your browser window
5. Click **Update IEP** to upload your PDF file
6. The document will be renamed automatically
7. To delete a document and start over click the **DELETE** button
8. Click on the document name to view the uploaded file
9. Each time you upload an IEP a second IEP upload table will be available for additional IEPs

- In the same row of the identified ID# on the right you will see the **Submission** column. If the application has been marked complete, it will say **Awaiting Director Certification** in red. Click **Submission**.

***If your school system has several applications, you can click on **Submission** for each application that says **Awaiting Director Certification** and continue with the certification process. You do not need to wait for each email or log in/out for each application.
